## CREDIT TERMS

Hattiesburg, MS 39402

- 1. If CR Fuels grants Applicant credit hereunder, Applicant agrees to pay CR Fuels in full the invoice price of all purchases now or hereafter made within (30) days from the date of purchase.
- Notwithstanding the terms set forth on each invoice, on public projects, if Applicant fails to pay the balance of this account within 15 days of receiving payment from the Project Owner, Applicant agrees to pay CR Fuels the penalty described in Miss. Code Ann. 31-5-27, as amended, in addition to the late payment charge described hereafter.
- If the total invoice price is not paid in full on or before the due date, Applicant agrees to pay a late payment charge of 1.5% per month on the unpaid delinquent balance, which is an annual percentage rate of 18%.
- In the event it becomes necessary to place this account with an attorney, Applicant agrees to pay all costs including an attorney fee of 33.33% of the outstanding balance that is then due, all costs of collections and collection agency fees.
- Applicant agrees that the terms of this Agreement shall be interpreted in accordance with the laws of the State of Mississippi, and that any lawsuit based upon the terms of the Agreement shall be filed exclusively in a state court of competent jurisdiction located in the Second Judicial District of Jones County, Mississippi.
